USING THESE SAME RESOURCES, THE HUMAN RESOURCES CONSULTANT PROVIDES AN ANALYSIS TO THE BOARD FOR ITS ANNUAL REVIEW OF THE COMPENSATION AND BENEFITS FOR THE EXECUTIVE DIRECTOR. THE BOARD MAKES THE DECISIONS ABOUT ADJUSTMENTS TO THE EXECUTIVE DIRECTOR'S COMPENSATION.

FOR THE PAST SEVERAL YEARS (SINCE 2020), GIVEN THE UNPREDICTABLE ECONOMIC ENVIRONMENT, THE RP GROUP HAS MORE HEAVILY WEIGHTED COLA DATA TO MAKE EQUITY-BASED RECOMMENDATIONS FOR SALARY ADJUSTMENTS.
